## **Yeditepe University Summer Education Regulations**

# **CHAPTER ONE**

#### **General Provisions**

# **Purpose**

**Article 1** – The purpose of this regulation is to determine the procedures and principles to be applied in the education program to be held in the summer months other than the fall and spring academic semesters at Yeditepe University and;

- a) To eliminate the irregularities in the academic programs of students,
- b) To reduce the number students in courses taken by a large number of students,
- c) To provide students from other universities with the opportunity to participate in the courses at Yeditepe University,
- d) To ensure the contributions of the academic staff outside the university, who are only available during the summer months, to Yeditepe University.
- e) To enable the evaluation of the content of education of Yeditepe University during summer months as well,
- f) To provide students with the opportunity to retake the courses that they failed to pass during fall and spring semesters during summer months.

### Content

**ARTICLE 2** – This regulation covers the provisions regarding summer education that is to be held at Yeditepe University at associate and undergraduate levels.

# **Legal Basis**

**ARTICLE 3** – This regulation has been prepared based on the basis of Article 27 of the Yeditepe University Associate and Undergraduate Education and Examination Regulations and the provisions of the Council of Higher Education and related laws.

# **CHAPTER TWO**

### **Definition and Principles of Summer Education**

#### **Definition**

Article 4 – Summer education is the education program applied during the summer months, excluding the fall and spring semesters of education, as defined in the 27th article of Yeditepe University Associate and Undergraduate Education and Examination Regulations. It is the education period that will be completed within seven weeks after a break of at least two weeks following the completion of the spring semester final exams.

## **Opening of Summer Education**

**Article 5** – Summer school opens with the decision of the University Senate. This semester lasts for seven weeks apart from the final exams, and the number of hours for each course is equal to the total number of hours taught in regular semesters.

The minimum number of students required to apply for the opening of summer education is determined by the relevant dean's offices, institute and college directorates. These numbers cannot be less than five in associate and undergraduate education and three in graduate education.

If the number of students enrolled in the courses offered in the summer education after final registration is below these numbers, the courses will not be opened. Unless the number of students exceeds thirty in theoretical courses and twenty in applied courses, a new section cannot be created for the same course.

### **Determination of Summer Education**

**Article 6** – Undergraduate courses that are to be offered in the summer education are determined by departments, faculties and higher schools; graduate education courses are determined by the relevant institute departments. Summer education is prepared on the basis of this information.

(Amended ON. 18.01.2007/26407 p.) The courses included in the normal education programs of the university are opened in the periods when it should be given, they cannot be postponed to the summer education period.

### **Application Method for Summer Education**

**Article 7** – The student who will apply for the summer education makes the pre-registration and final registration between the dates determined in the academic calendar. A student can normally take a total of 2 courses in summer education. This number can be increased to 3 with the decision of the relevant Board of Directors.

The students who have exmatriculated cannot apply for summer education. If the student has pre-registered before exmatriculation, the registration process will be cancelled.

### **CHAPTER THREE**

#### **Evaluation of Grades**

**Article 8** – The grades of the courses taken in the summer education are evaluated according to the provisions of the Yeditepe University Associate and Undergraduate Education and Examination Regulations published in the Official Newspaper dated 9/6/2000 and numbered 24074.

The grades taken from the summer education courses are shown in a section opened with this name in the transcript and these grades are included in the calculation of the GPA.

Those who complete the sufficient credit score by continuing the summer education can graduate in this period. Students on probation cannot take courses from the next semester after the semester they are in during the summer education.

### Validity

**Article 9** – This regulation enters into force on the date of its publication and is to be valid from the 2003-2004 academic year.

#### **Execution**

**Article 10** – The provisions of this regulation are executed by the Rector of Yeditepe University.
